³⁵₁₇ Melissa McVay, Senior City Planner, Department of Transportation & Engineering, regarding resurfacing and possible improvements of Delta Avenue next year.

- Work is from Erie to Columbia Parkway
- At this time the proposed plan is as follows:
 - Incorporate a bike lane
 - Provide a center turn lane
 - All existing parking to remain
 - Provide a new light at Kroger and Delta
 - Work to start spring of 2014
 - These changes will make crossing Delta safer for pedestrians.
- Section drawing of Delta was distributed.
- The city Department of Transportation & Engineering will return to the MLCC when the plan details are developed.
- Question from MLCC: What about rush hour, will this plan create more traffic back-ups?
 - Answer: Studies show that the type of plan features does not increase congestion.
- Question from MLCC: When will the plan be decided?
 - Answer: The final plan must be decided by fall of 2013.
